I, the undersigned authority responsible for having the official ballot prepared for the 2024 Election of the Board of Directors of the Panola County Groundwater Conservation District ("District"), certify the following with regard to the election for the office of director, which was called to be held on November 5, 2024:


- (1) The election order entered by the District on July 30, 2024, called for elections to be held in Panola County, Texas, on November 5, 2024, for the purpose of electing directors for the District: a regular election to elect four directors; one in each of the Panola County Commissioner Precincts One, Two, Three, and Four, each of whom shall serve a four (4) year term.
- (2) August 19, 2024, at 5:00 p.m. was the deadline for persons to file an application to have their name printed on the ballot as a candidate for regular election to the office of director at the election scheduled for November 5, 2024.
- (3) August 23, 2024, at 5:00 p.m. was the deadline for persons to file a declaration of write-in candidacy for the regular election to the office of director at the election scheduled for November 5, 2024.
- (5) The only persons who have filed an application to have their names placed on the ballot are as follows:
