### PUBLIC HEARING AGENDA – PERMITS

1. Call to order.
2. Public Comment- Comments are limited to 3 minutes. No action will be taken unless provided on the agenda.
3. Hugh Brinson Pipeling, LLC. of 1300 Main Street, Houston, TX 77002, applied for a permit to operate one (1) water well located at 592 PR 8015, Carthage, TX 75633 for industrial (facility) use. The potential maximum annual groundwater production from this well in gallons and estimated maximum rate of withdrawal in gallons per minute (gpm) are shown below:

Well Name	Potential Maximum Annual Production	GPM
Hugh Brinson Pipeline Facility	6,307,200	12

The total usage applied for is 100,000 gallons or 0.31-acre feet annually at the rate of 12 gallons per minute.

4. Jonathan Mussey. of 400 CR 312, Marshall, TX 75672, applied for a permit to operate one (1) water well located at County Road 312, Carthage, TX 75633 for agricultural (irrigation and livestock) use. The potential maximum annual groundwater production from this well in gallons and estimated maximum rate of withdrawal in gallons per minute (gpm) are shown below:

Well Name	Potential Maximum Annual Production	GPM
Well #2	10,512,000	20

The total usage applied for is 5,000,000 gallons or 15.35-acre feet annually at the rate of 20 gallons per minute.

5. Pinnergy, LTD of PO Box Drawer B, Carthage, TX 75633, applied for a permit to operate one (1) water well located at FM 3359, Carthage, TX 75633 for Oil & Gas (frac) and facility use. The

potential maximum annual groundwater production from this well in gallons and estimated maximum rate of withdrawal in gallons per minute (gpm) are shown below:

Well Name	Potential Maximum Annual Production	GPM
Deadwood SWD #1	63,072,000	120

The total usage applied for is 63,072,000 gallons or 193.56-acre feet annually at the rate of 120 gallons per minute.


